• Technician Austin gave an update on the seed program.

Watershed Reports

- Manager gave a brief report for each watershed.
 - Yellow Medicine River One Watershed One Plan
 - Manager worked with Michelle on projects that need funding for cover crops. Manager advised the watershed that we could utilize \$500,000 for people waiting to sign up. Suggested that we sign up for extra dollars from the \$7.7 million left over state wide.
 - CRP incentive grant. Sent Michelle an email suggesting what our landowners suggested to Austin in regards to incentives in the flood plain area. Get the CRP payment up to \$300/acre.
 - Policy meeting I was unable to attend.

• Lac Qui Parle River Watershed One Watershed One Plan

Submitted a cover crop contract. Our first contract with the 1W1P

Missouri River One Watershed One Plan

- Conservation Agronomist Position Justin Decker spoke to the group. He used to work for the Rock SWCD 13 years ago. He comes with a lot of knowledge in the field and is very personable.
- o 2024/2025 grant will be for \$2,096,184
- o Increasing the incentive amounts for soil health practices. Total not to exceed \$100,000 for tillage and cover crops combined.

Redwood Watershed- Local plan basin project

O Planning Kick off Meeting December 8th. Ron Bunjer is assigned to the Redwood.
